5. Collier County “ Municipal spelling” governed by Constitutional rule of law / pursuant to law or COLOR OF LAW and or APA
6. COLLIER COUNTY “ FULL CORPORATE CAPACITY” governed by COLOR OF LAW and or APA
7. state of Florida “Constitutional spelling” governed by Constitutional rule of law
8. State of Florida “ Municipal spelling” governed by Constitutional rule of law / pursuant to law or COLOR OF LAW and or APA
9. STATE OF FLORIDA “ FULL CORPORATE CAPACITY” governed by COLOR OF LAW and or IDAPA
10. Can the STATE provide they are the General Executrix for the ALL CAP NAME ESTATE in this matter which the Creditor in Honor maintains.
11. All presumed crimes are COMMERCIAL CRIMES according to 27CFR 72.11
12. Provide all COMMERCIAL bonds attached to this case, example: Payment Bond, Statute Performance Bond, Bonds Statute Payment, Bid Bond, REINSURANCE AGREEMENT IN FAVOR OF THE UNITED STATES etc.
13. Provide evidence the General Executrix is NOT a living being created by God, not a GOVERNMENT CORPORATION “Entity” as the STATE claims subject matter jurisdiction without contractual consent.

True Name / Patronymic Name is the one recommended under termed as Certified photocopy by the Florida VITAL RECORDS as shown on the form Florida VITAL STATISTICS CERTIFICATE REQUEST.

APA = Administrative Procedure Act
